#### **Health Inequities**

Social inequities in health are systematic differences in health status between different socioeconomic groups.

These inequities are socially produced (and therefore modifiable) and unfair.

#### **Social Determinants of Health**

Determinants of health are factors that influence health positively or negatively and that can be influenced by political, commercial and individual decisions, as opposed to age, sex and genetic factors, which also influence health but are not, on the whole, open to influence by political or other types of policy.

# Conclusion

- Health Equity is strongly on the EU agenda
- The agenda setting reflects a broader change in the discourse on Public Health > new era of collectivism in public health?
- Improving population health significantly requires the improvement of the health of those worst-off
- Closing the gap between socioeconomic groups is not possible by the action of health sector alone
- Mainstreaming health equity considerations in health policy and health considerations in other policies is the main challenge
- Changing the words into concrete action requires data
